### The Purpose of the Annual Meeting

The annual meeting is a chance for us to receive a summary of the previous year's progress and/or challenges and a reminder of what the vision for the upcoming year entails. In years when there are matters to be voted on, a forum will be held before the day of the meeting so that people can ask questions and speak to issues. On the day of the vote, there is no further discussion. On years when there is no vote, the meeting is simply to share reports with those who are interested. A compilation of reports will always be available in print for those who want them who were unable to attend the meeting.

### How is Information Available During the Year

- 1. All Cathedral board meetings are open and can be attended by every member. One must be on the agenda to speak, but the business that is handled by the board is open for everyone to witness. The board meets 10 times per year (second Tuesday of most months at 7 pm).
- 2. The Financial Health Team meets, as scheduled, At that meeting, the entire ministry plan is discussed line by line. All questions are welcome and are answered. The FHT is made up of staff and Cathedral Board, but any Cathedral member may attend the meeting and at that meeting may ask any question about church finances.
- 3. All staff members are available to the congregation by phone or email. You can always ask a question. If the person you ask isn't the best person to ask, she or he will refer you to the proper authority.
- 4. The *Sun Burst* is published weekly. That publication contains multiple pages of information every week throughout the year. Highlights from the *SunBurst* are also sent out most weeks by email. Archived copies of the *SunBurst* can be found on the church website.
- 5. Weekly and monthly financial reports are emailed by the Minister of Administration to the Cathedral Board and posted on the Cathedral's web site <a href="https://www.sunshinecathedral.org">www.sunshinecathedral.org</a>.
- 6. Announcements are made at the beginning of every worship service, and slides with information are rotated before each service.
- 7. Additional information can be found on our website and on the church's Facebook page.
- 8. In addition to these many ways of staying informed, there is an Annual Meeting every January where information is summarized and shared.

### **Conduct for Public Meetings**

Our rules for discussion for all Sunshine Cathedral meetings, classes, and forums are based on the V.I.S.I.O.N.S. model. (V.I.S.I.O.N.S. is a multi-cultural, diversity training and consultation firm committed to anti-oppression work):

- 1. It's OK to disagree.
- 2. Do not blame, shame, or attack anyone
- 3. Practice both/and thinking (as valid as your opinion may be, it probably isn't the only valid opinion and there is probably more than one way to accomplish any worthy goal)
- 4. Be aware of intent and impact (our intentions are usually good, or at very least neutral, but our words and actions may impact others more negatively than we had intended)
- 5. "Try on" new ideas before dismissing them or reacting negatively to them
- 6. Practice self-focus (rather than belittling or insulting someone with a different view, we can simply own our own feelings by saying, "I feel" or "I think" or "I would prefer" rather than "you're wrong" or "what were you thinking?!" or "that's stupid." Also, we speak only for ourselves; we are never the spokespersons for unnamed, faceless "others" (the infamous "they" or "everybody" that are often invoked to persuade an ideological opponent)

By using these simple guidelines for discussion, there is no topic that we can't discuss and even when we disagree, we can do so in ways that are helpful, respectful, and that will build us up rather than tear us apart. By committing to respectful dialogue, even our disagreements can be part of a healthy process that will contribute to the vitality of our congregation.

### **Direct Dealing**

We have a direct dealing policy at Sunshine Cathedral. Public meetings are not the place to initially air grievances. When we have conflict or a misunderstanding with someone in church leadership, the FIRST step is to speak with that person directly. If that proves to be unsatisfactory, then the SECOND step is to speak with that person and a mediator. If that doesn't work, then speaking to someone's supervisor might be in order.

It is always appropriate to ask questions before making accusations, and one should always deal directly with a person rather than resorting to triangulation tactics (going around a person or behind the person, trying to vilify the person to others or build a coalition against the person before a direct discussion with the person has even taken place). Triangulation is considered antagonistic behavior and is unworthy of any principled organization, and especially any organization founded on a commitment to spiritual growth and vitality.

If there are questions about fiduciary concerns, the FIRST step is to ask questions of the Administrative Staff . That should almost always settle the matter as a member of the Administrative Staff is the person with the most current and complete information about all financial matters. However, if you feel that the Administrative Staff has not responded to you sufficiently, you should attend a Financial Health Team meeting. At that meeting every line item is addressed and every question that is raised is answered. In the unlikely event that the first two steps didn't answer your questions satisfactorily, you can then ask to be added to the agenda for a Board of Director's meeting. Once on the agenda, you can make a statement to the board which will listen to you and will decide if further action is warranted.

Offering a safe and open community for people to worship, learn and grow in their faith is our deep desire. We are committed to equipping ourselves and each other to do the work that God has called us to do in the world.

### Spiritual Transformation

Providing a message of liberation from the oppressive religious environment of our day or to those experiencing God for the first time is what guides our ministry. We believe that when people are invited to experience God through the life and ministry of Christ, lives will be transformed.

### Social Action

Working to talk less and do more, we are committed to resisting the structures that oppress people and standing with to those who suffer under the weight of oppressive systems, being guided always by our commitment to Global Human Rights.

Sunshine Cathedral strongly promotes MCC founder Troy Perry's original Three-Pronged Gospel:

- ~ Christian Salvation (saved from hopelessness, degradation, & despair)
- $\sim$  Christian Community (modeled after the healing love demonstrated by Jesus, inclusive of those who identify as Christian and those who don't)
- ~ Christian Social Action (justice work to build the kin-dom of God on earth)

And Sunshine Cathedral shares the values articulated in the Mission and Vision of the International Council of Community Churches:

Mission: "As people devoted to following Christ we are committed to community, to treasuring diversity, to living our faith in service and love."

Vision: "To affirm individual freedom of conscience, protect and promote congregational self-determination, proclaim that the love of God – which united – can overcome any division, be an integral partner in the worldwide ecumenical movement."

### January 17, 2021 Meeting Called to Order at 12:01 PM

- i. Call to Order
- II. Opening Prayer: The Dr. Rev. Durrell Watkins lead an opening prayer.
- III. Roll Call: The Chairperson of the Board, Mary Fedoration, confirmed that with 37 members in the room and 7 participating via Zoom, therefore, Sunshine Cathedral had met the quorum to conduct business.
- IV. Approval of Board Minutes: Dr. Rev. Durrell Watkins provided an overview of the 2019 Annual Meeting minutes. The minutes were approved by unanimous consent.
- V. Proposed Change to By-laws: Dr. Rev. Durrell Watkins presented a proposed change to the by-laws, previously approved by the Board of Directors. The change would reduce the number of required Board Members from ten to eight. The rationale for the change is it is hard to get people to volunteer, the lower number will allow the Board to operate in compliance with the By-laws. After the Call for Discussion, there were no questions or comments. Rev. Ren Bell made a motion to accept the proposed change. Dennis McWilliams-Ramos seconded the motion. There was no discussion. The motion carried with unanimous consent.

### VI. Reports

- <u>Senior Minister's Report</u>: The Senior Minister's report is included via reference and is available in the church office. Dr. Rev. Durrell Watkins' annotated remarks follow.
  - The SC Foundation was very helpful this year with 7 months of financial aid (\$8,000) per month. That helped us meeting our obligations during 2020.
  - HAF Foundation, Our Fund, and member giving, remains strong. Some members increased their giving and others converted to on-line giving. Revenue from Internet donations is growing.
  - Since beginning HappeningOut, the team that produces the Sunshine Cathedral Worship service, we have achieved approximately 5 million contacts with people around the world. Our relationship with HappeningOut is afforded by generous donations from the congregation and a barter arrangement. We provide office space to HappeningOut and we received discounted services.
  - The food sharing program has made a major contribution to the community.
     Strong donations and many volunteers are helping to meet the needs of food insecure members of the community at large.

- Please keep doing what you are doing and if you can offer more, it is always
  welcome. Think about becoming a Pillar. A Pillar is someone who leaves a
  bequeath to Sunshine Cathedral.
- Financial Report: Trevor Stewart, Treasurer, provided an overview of the financial health of Sunshine Cathedral. The Treasurer's remarks are summarized.
  - Sunshine Cathedral ended the year with approximately \$7,000 in reserve. This
    is phenomenal, especially given 2020.
  - The balance of the PPP "loan" program of \$48K will be forgiven as soon as the paperwork is available from the bank. Sunshine Cathedral met the requirements for forgiveness. Once that is forgiven, Sunshine Cathedral will have a positive cash balance of \$50K.
  - As soon as we can apply for the second round of financial aid, we will file the paperwork.
  - During 2020, there was never a need to hold payroll checks. This was a result
    of everyone doing their part to help meet our obligations.
  - Sunshine Cathedral had a \$500k budget and ended the year with almost a zero balance.
  - For 2021, we have cut \$127K from the budget. This comes from; no salary or stipend increases, postponing new staff (musicians and clergy positions), and reductions in stipends.
- 3. <u>Sunshine Cathedral Foundation Report</u>: Phil Chesney, Chairperson of the Sunshine Cathedral Foundation provided a report from the Foundation. The Chairperson's remarks are summarized below.
  - The Foundation fiscal year is July to June. CORRECTION: OPERATES ON A CALENDAR YEAR.
  - 2021, will begin a three-year Capital Campaign. The goal is to raise \$300K.
    The Foundation will tithe back to Sunshine Cathedral, contributions to this
    campaign. We need to raise approximately \$20K per year for anticipated
    capital expenditures, for example; roof replacement, air conditioning, and
    other capital expenditures. Both are approaching the end of the useful life.
    A flyer detailing the Campaign is in the church office.
  - The Ambassador Club membership is open to anyone contributing at least \$500.
  - Jack Hunziger was a Pillar. As a result, and at his request, we were able to complete the stained-glass doors on both sides of the sanctuary. Jack was a blessing to Sunshine Cathedral.
  - The timing of HappeningOut, right before the Covid-19 lockdown, allowed us to continue our worship services even with the sanctuary was closed. Unfortunately, and at the same time, we needed to replace a sound board and three projectors. Donors provided the funds.
  - Financial Board membership has been changing and anyone interested in joining the Foundation are welcome.

### January 16, 2022 Annual Meeting Senior Minister's Report

Dear friends and co-laborers,

### We (SC) reached about 6 million people in 2021.

We ended 2021 in the black.

We are starting 2022 with some well-established and still thriving programs, and with some brand new and very exciting programs. Below is a lot (never all) of what we have going on as of right now. We are an amazing church doing amazing work in the name of the God we know as Infinite, unconditional, all-inclusive, Love.

### **WELLNESS MINISTRIES**

Food Sharing – Pantry open to public on Wednesdays (no questions asked) & preprepared lunch bags available & shared with individuals and community organizations (i.e., a recovery group, a Section 8 Housing community, a health care facility, the local Salvation Army, 2 Assisted Living Facilities that serve formerly homeless veterans, Broward House [HIV services], Women in Distress (responding to domestic violence], & Latinos Salud [safe haven for Latinx gay/lesbian, transgender, and HIV+ persons])...people served include transgender individuals, people of color, families, Queer people, Spanish speakers, & people living with HIV.

Bereavement Group - twice monthly

Covid Testing – 7 days per week at Sunshine Cathedral Square

Broward House STI Testing – 1 day per week at Sunshine Cathedral Square

Condoms (male & female) in SC bathrooms (provided by Pride Center)

SAGE – Friendly Visitor Program for LGBTQ seniors at Sunshine Cathedral (in the works)

Twelve Step Groups – meet at Sunshine Cathedral Square

Noble A. McArtor Center at SC Square (for seniors)

Various SunServe services at SC Square

### **PERFORMING ARTS**

We are so proud of our performing arts program (Sunshine Cathedral Performing Arts Center). The events are mainly held in the Lawrence/Lewis Center for Worship & the Arts, but we are starting to call the program itself: Sunshine Cathedral Performing Arts Center.

You know we've featured big names and amazing talent. Fran Drescher, Jackie Hoffman, John Waters, Suzanne Westenhoeffer, Leslie Jordan, Lorna Luft, Randy Rainbow, Steve Grand, Melinda Doolittle, Wilson Cruz, and the Yale Wiffenpoofs are just a few of the stars to wow us at Sunshine Cathedral.

This season, we are thrilled to welcome Miss Richfield 1981, Varla Jean Merman, Miss Coco Peru (always a hit at SC), Joana Gonzalez (pianist), and Laith Ashley (model, singer, trans-activist). There are negotiations already for some sterling talent in the Fall and Winter.

These performances bring people to Sunshine Cathedral Square, help raise funds for Sunshine Cathedral ministry, offer joy and connection to our community, celebrate our community, and show that spirituality, the arts, daily life, and LGBTQ issues can all be embraced in one dynamic, diverse community. While we are

non-sectarian and non-dogmatic, the ministry of love, the message of hope, and the power of goodwill are things to which we are fiercely committed, and the Arts are an important and effective way of sharing this unique ministry.

### **PASTORAL CARE**

- +Pastoral visits can be arranged for those who are hospitalized or home bound.
- +We have trained prayer partners to support people, at no charge, with the loving energy of prayer.
- +We offer worship services at Presidential Place, an Assisted Living Facility.
- +Afterlife care is offered via the Sunshine Cathedral Columbarium and Memorial Chapel.
- +Those with clinical mental health needs can access our friends at SunServe.

### PRAYER MINISTRY

Our prayer ministry is called Silent Helpers. People you may not know are silently offering help by holding those on our prayer list in loving prayer. Our prayer partners are ministers, deacons, certified practitioners/ prayer chaplains, and a few lay leaders who have taken spirituality classes and who are active in the faith community. There are over 50 such Silent Helpers knowing with and for each person on our list that God, Omnipresent Love, is right where they are and in God's presence, blessings abound.

### The Prayer ministry offers:

- +A Prayer List (published weekly in the Cathedral newsletter, the Sun Burst) people stay on the prayer list for at least 4 weeks.
- +Prayer Chaplains (Silent Helpers) receive the prayer list, an inspiring quote, and a written prayer every week.
- +Staff prayer most Tuesdays, the executive staff prays for every person, by name, on the prayer list. After naming each person, the staff sits in sacred Silence for a time and then, in unison, recites a prayer.
- +Board prayer each Cathedral Board of Directors meeting opens in prayer and the prayer includes not only seeking guidance for the board and blessings for the congregation, but also good wishes for all who are on the Prayer List.
- +Dial-A-Prayer there is a recorded prayer one can access 24 hours per day: 954.462.2004 (press 6)
- +Sunday worship is prayer filled...prayers are spoken and sung, affirmations are used, blessings are offered. In worship, we pray for the congregation, for those who are on our hearts, for world leaders, for world peace, and more.

\*DSFI is the headquarters of the Divine Science community. DS is founded on the experience of God as omnipresence, and as all and only good (the very message of Sunshine Cathedral). Our senior minister holds a couple of ordinations, and one of them is with Divine Science; he is also currently the president of DSFI and the Sunshine Cathedral is the current home of the DSFI offices and archives. The Samaritan Institute is recognized as a Divine Science ministry training school.

### **BRICKS, MORTAR, & LEGACY**

Sunshine Cathedral Foundation, with Sunshine Cathedral, has launched CC 5, a \$330,000 capital campaign to improve the property (to include a beautiful exterior mural).

### **JUSTICE MINISTRY**

You will frequently see pastoral statements or prayers in response to injustices, and you often (more often than not) will hear justice focused on in sermons (restorative justice, equal opportunity, peace, goodwill, compassion, generosity...these are hallmarks of the kin-dom of God). Marches, demonstrations, letter writing, petition signing and more wax and wane as circumstances dictate, but our focus on justice-love remains constant. Additionally, we support and work closely with the Global Justice Institute and BOLD Justice to help make a more just world and community.

### **EDUCATION**

- \*We have new and archived video presentations online (Just A Thought, Christians & Cocktails, Share in the Chair, Book Discussions, etc).
- \*Preaching remains a time-tested way of helping people explore the deep mysteries of life.
- \*The Sun Burst offers bios of spiritual heroes every week.
- \*We have an on-going A Course in Miracles group.
- \*The Samaritan Institute is now using the archived videos, previously used correspondence courses, personal mentoring with a qualified teacher/coach, guided reading, and assessment of prior learning to help adults prepare for and demonstrate proficiency in areas of ministry (diaconal ministry, prayer chaplaincy, etc.).
- \*The Samaritan Institute also publishes Spirit in Action (for DSFI and it serves the purpose that Spirit & Truth did for years) which is both an educational tool and a spiritual practice aid.

### SUNSHINE CATHEDRAL GLOBAL FELLOWSHIP

We are intentionally connecting people all over the world to the work and witness of Sunshine Cathedral. People are getting our emails, watching our services, sharing their prayer requests, making donations, visiting Sunshine Cathedral Square when they are in the area, reading our daily reflections and prayers on Facebook, pledging support to the Global Fellowship and/or to the broadcast ministry, and are even being offered opportunities to connect via Zoom. We've had Global Fellowship partners volunteer when visiting Sunshine Cathedral Square and we've had very generous donors from North Carolina, Georgia, New Jersey and Tennessee, and viewers who connect with us with comments and prayer requests from Egypt, the UK, Belize, Mexico, the Philippines, California, New Mexico, Arizona, Canada, New England, and more. We've reached people in over 6,000 cities in the world so far.

Our Global Fellowship will even have the opportunity to meet local congregants when we travel to Italy in April. The Global Fellowship is new and we are still working to improve it, but so far, it's off to a very good start. As a bonus, those who officially join the Global Fellowship get a bit of SC swag.

### **WORSHIP**

Worship has evolved quickly and repeatedly in Pandemic. We are so grateful to volunteers and paid leaders who have stepped up or back as needed to keep us all safe and also provide a

high-quality worship experience. Our message remains a social gospel (aka, the gospel) and our commitment to making ourselves fully available to people wherever they are (including some out of the box thinking about sharing communion) has helped us thrive in pandemic and reach more people than ever before. Our worship remains blended, contemporary and traditional, profound and whimsical, courageously exploring deep mysteries with light hearts, religious and secular (but always spiritual), prayerful, scriptural (with a willingness to read against scripture and to challenge interpretations of scripture that have been used abusively), cathartic and joyful.

### SUPPORTING SUNSHINE CATHEDRAL

We try to make supporting the Cathedral easy.

- ~With estate planning, people can leave Sunshine Cathedral financial gifts.
- ~By supporting capital campaigns, Sunshine Cathedral supporters help the physical property thrive (our theatre seating, 4 manual organ with Italian pipes, parking lot repairs, roof repairs, amazing mural that is in process, our chancel and, indeed, possession of the property itself and the fact that the property is mortgage free are all results of capital campaigns).
- ~There is a Sunshine Cathedral Fund at Our Fund. The fund earns money that helps fund Sunshine Cathedral endeavors. People may contribute to the Sunshine Cathedral Fund at Our Fund.
- ~When people attend events at Sunshine Cathedral, that helps us do ministry. The events, because they bring people together to experience joy and possibly empowerment, are ministry, and they also help fund other ministry work. When people attend events at Sunshine Cathedral, they are helping Sunshine Cathedral thrive.
- ~Donations can be given in a number of ways: during the offering collection in worship, handing an envelope to any staff member, mailing donations (USPS), Text to Give, Venmo, CashApp, the giving kiosk, or giving through the website. Because we depend on and appreciate gifts freely given, we try to make it as easy as possible to give.
- ~Money is good, but food is also something people can give. Non-perishable food items donated to the Food Sharing ministry helps fight food insecurity in our community.
- ~Time is also a valuable gift, and those who give time to help (office volunteers, sound and light helpers, ushers, garden team, deacons, members of boards, etc.) make a lot of what we do possible.

### **BARGAIN STAFFING**

Along with a leap of faith or two in pandemic, we also planned ahead with caution and backup plans. From a financial perspective, the last two years have been among our best ever, and Christmas 2021 was the most prosperous Christmas of my SC tenure to date (God bless our Christmas Angels!).

That we do so much with so few full-time staff is amazing, and our part time staff and volunteer staff make that possible.

Durrell Watkins, DMin (senior minister), Robert Griffin, DMin (executive minister), and Anne Atwell, DMin (minister of connections) are our full-time clergy people, and our only full time staff at this time. We are unique in having the three most senior members of our Executive Staff all holding earned doctorates in their field.

Part-Time (in title anyway) staff members are: Kevin Tisdol, MA (Education), Barbara Ramcharitar, MA and Sara Burns, BA (co-directors of worship arts), and Kurt Litzenberger, BS (Artist in Residence, Lights, Sound, and Set Design)

Then our contract workers (they are contracted for a specific task) are: Darren Loli, BS (Director of Communications), BK Hipsher, DMin (another doctorate...SC Second Life Minister), Sam Miller, MFA (Videographer), Musicians...Tara Sparry, MM, Gabe Salazar, MM (Artistic Director of GMC SF), Aaron Ball, MM, Teresa Flores, MM, Felipe Diaz, BM, Laura Gonzales (BM in process), David Suarez, BM, Cheryl Barth, BA

But then we have unpaid leaders who help us so much. All deacons are unpaid (Michael Karban, Dr. Ed Huckemeyer, Lydya Chapman, Dr. Sue Gallagher, and Jean Johnson). Phil McChesney and Gary Lane are unpaid musicians. Margarita Rodriguez, Lynda Pantoja, Marian Cavagnaro, Kurt Krieger, Nancy Davis, and Ren Bell are all unpaid clergy (who actually help us a lot).

The choir was volunteer and when we couldn't safely have a choir for a long time, Penny Sanfilippo, Twila Wilson, Charles Robinson, and Bill Spinosa pitched in as an ensemble and were a godsend. We are blessed to have a compensated, professional music staff leading us. Volunteer musicians will likely join us again in the future.

18 paid people on staff (sounds like a grand Cathedral)...however, 15 of them are half time or less. And that amazing team is aided by a virtual army of volunteers, including 14 or so who hold key leadership positions without taking a dime (including our Accountant, Trever Stewart and our Lead Usher, Peggy Brereton).

The truth is, our 18 paid people cost us about what 7 full time people would. To get this level of professional-ism from this amount of people for the bargain amount we pay is a miracle. It's part of the amazing Sunshine Cathedral story. We make it work. We do more than others might think possible. And then, we seek to raise the bar again.

That's how we look almost 2 full years into Pandemic. I'm pleased. I hope you are, too.

Dear Sunshine Cathedral members and friends.

2021 was an interesting year! Just when we thought everything was heading towards a more "normal" way of being, COVID-19 had other ideas. And, yet, the Connections ministry at Sunshine Cathedral remains strong, healthy, and very busy.

In 2021, the ongoing issue of food insecurity remained the focus of the Food Sharing Ministry. During 2021, this outreach ministry provided over 28,000 assists which was an increase of 7.6% over 2020. The need remains and Sunshine Cathedral continues to offer a "no questions, no judgment" outreach to all those who require food assistance. We anticipate even greater growth and outreach throughout 2022 with the addition of the Climate-Controlled Food Storage Container that will be located on the Sunshine Cathedral property.

We have been able to continue the Food Sharing outreach through partnerships with Feeding South Florida, The United Way/Project Lifeline, The South Florida Hunger Coalition, The Pantry of Broward, the very generous spirit of the Sunshine Cathedral congregation, and financial donations from other local organizations. And the Food Sharing volunteers have gone above and beyond this past year to ensure that anyone who comes to Sunshine Cathedral in need of food will not leave empty-handed. Thank you, all!

The Bereavement Group continues to meet at Sunshine Cathedral on the second and last Monday of every month. The group remains active and the attendance has been very good throughout the year. When the group attendees were asked if they would like to meet at another location, they unanimously said "no!" There is a feeling of safety and sanctuary here at Sunshine Cathedral which the participants appreciate.

Deacon Ed Huckemeyer continues to serve in the area of Pastoral Care. Deacon Ed and his team are a constant presence to those who just need a reminder that they continue to be part of the Sunshine Cathedral community. Over 1,300 contacts were made by the Pastoral Care Team in 2021. If you know of someone who would benefit from a phone call, an email, a card, or a visit, please contact either Deacon Ed or me and the connection will be made.

#### **SUNSHINE CATHEDRAL FOUNDATION ANNUAL REPORT 2021**

2021 continued to be a year of unprecedented challenges and remarkable resilience and accomplishment, thanks to extraordinary collaboration, generous supporters and harmonious teamwork in cooperation with and support of the Sunshine Cathedral Ministry Team, Cathedral Board, and dedicated volunteers and partners committed to the mission and ministry of the Sunshine Cathedral.

In 2021 we were saddened by the loss of Paul Fasana, long-serving Board Governor and most recently a member of our Heritage Board, as well as the loss of several prominent benefactors and supporters of the Cathedral. At the conclusion of 2021 Bob DeCamillo and Bobbye Schuler, both long-time Foundation Board Governors, will transfer to the Heritage Board. Bobbye also has served the Foundation as its Bookkeeper for many years and we are grateful for their service.

With a new year – 2022 -- comes new growth. We searched for and found a new Bookkeeper who has already begun working with Bobbye during the transition, effective this month. Additionally, we have recruited two new Board members. Attendance at meetings has been good, although we, like many others, have had to become accustomed to virtual Zoom meetings. (Anyone who is interested in serving on our Board is encouraged to make your interest known to myself, any Board Governor or minister.)

The Foundation Board of Governors has marked this year with several accomplishments and a continued commitment to future service and support. These accomplishments and future objectives could not be possible without the financial commitment and service of our Ambassadors Club members, the generous bequests of our Pillars Foundation donors, our Capital Campaign contributors, and the support of each of you.

In addition to normal campus facilities repairs and maintenance, the Foundation exemplified its commitment to the "virtual bricks and mortar" of the Sunshine Cathedral Global Fellowship by funding the purchase of new cameras and equipment for the Walt Lawrence and Stephen Lewis Center for Worship and the Arts. This expenditure, in addition to the substantial investment of high-cost equipment provided by HappeningOut television, will enhance presentations and the viewing and listening experience of participants from across the country and around the world, bringing them "inside" the worship and performance space. Furthermore, apart from an enhanced live experience, the various performing artists and events that come to the Center for the Arts will be available in high quality, on-demand format – both paid and unpaid.

Other improvements included a new replacement air-conditioning split system for our second floor office and classroom space above the chapel, as well as an eco- and bee-friendly bee and hive extraction from the administration building. The Sunshine Cathedral Columbarium continues to provide a serene space and peace of mind for many as they plan for the future.

In 2021, the Foundation concluded its search and review and selected a new insurance agency to serve the growing needs of the programs and facilities of the Sunshine Cathedral campus. All policies have been reviewed and revised where necessary, including a consolidation of providers as well as on-going assessment of new events and activities to ensure minimal risk and mitigation. The Foundation also proceeded in its commitment from 2020 to set aside and earmark reserves (approximately \$20,000 annually) to be used for the projected roof replacement of each of the campus buildings when the time comes, as a result of the continued blessings of the Sunshine Cathedral Fund at Our Fund and the regular dividends apportioned between the Cathedral and the Foundation.

With the advent of the 50<sup>th</sup> Anniversary of the Sunshine Cathedral in October 2021, the Foundation launched a three-year <u>"50<sup>th</sup> Anniversary Capital Makeover Campaign"</u> to raise \$330,000 for many needed and exciting updates and improvements which will better positon the Sunshine Cathedral to serve and minister to the greater community (in-person and virtual) for the <u>next</u> 50 years. We are excited to have already raised total donations and/or commitments of nearly \$75,000! Some of the exciting projects underway include a mobile mini storage unit for the Food Sharing Ministry and a multi-story/multi-building courtyard improvement and mural project. Stay tuned for more details to come.

We continue to work from our strategic plan to further develop our Core Services and Key Objectives to continue to support the ministry and mission of the Cathedral for future years:

- Core Services
  - a. Secure and maintain church property and equipment
  - b. Stewardship for Pillars Society, legacy giving, endowments, and Ambassadors Club
  - c. Support capital and facility needs per church leadership and vision
  - d. Be advocates and ambassadors for the vision of the church
- Objectives and Priority Actions
  - Maintain a safe and attractive facility

- o Recruit and maintain an active Board of Governors
- o Meet current and future capital needs
- Be advocates and ambassadors for the vision of the church

In summary, the Board is committed to doing whatever it can to ensure our church community and campus continues serving the many people who come to our church and campus every week and who visit it virtually on-line through its broadcast ministry. We are also committed to being working partners with our ministers and church staff.

As Foundation Chair, I have continued to be blessed by the on-going support of the Board of Governors, including our Vice Chair, Keith Muller; Tom Fedoration, Treasurer; Santiago Madrinan, Secretary; and Bobbye Schuler, our invaluable Bookkeeper, who has taken care to ensure a successful and comprehensive transition with our new Bookkeeper, John Kent. Tom is stepping aside from the Treasurer role at the end of 2021 and we are thankful for his service as well as continued commitment as a Foundation Board Governor.

[Please note that no member of the Board of Governors is paid for the work they do on behalf of the Foundation. An outside accounting firm audits our books annually.]

### 2021 Accomplishments

The major activities and accomplishments of the Sunshine Cathedral Foundation are:

### 1. FACILITY MANAGEMENT

Again, this year the Foundation was been able to support projects proposed by our ministers during this past year. Our Facilities team continues to review and update a programmed schedule of future needs, matching anticipated capital improvement needs with available or projected resource, including addressing ongoing needs of Cathedral Square and emergent repairs. The Foundation Board of Governors followed its 2020 plan to apportion funds towards reserves for projected future capital improvements/upgrade (roof replacement for each of the campus buildings). As we look to the current year and beyond, we will focus further on campus beautification and upgrades and improvements, with emphasis on the projects identified in the Sunshine Cathedral 50<sup>th</sup> Anniversary Capital Make-over Campaign.

#### 2. COLUMBARIUM

The Sunshine Cathedral Columbarium continues to provide a beautiful and meditative final resting place for many past Cathedral members and friends as well as peace of mind for future planning for many current members. In 2022 we will consider the addition of new niches in anticipation of continuing demand.

#### 3. AMBASSADORS CLUB

Members of the Ambassadors Club support the Foundation with unrestricted gifts of at least \$500 per person (or \$1,000 per couple) each year. These gifts support the Foundation's administrative costs and outreach efforts.

### 4. PILLARS SOCIETY

The "Pillars Society" is the heart of our program to secure our future. It the major method the Foundation must establish long-term investments and an endowment fund to support the Foundation, our Cathedral, as well as SunServe. Upon request, Pillars Society funds are used to support various needs of the Sunshine Cathedral; some funds are restricted, and the donors' wishes regarding how to use those funds are honored. The Sunshine Cathedral Foundation and the Sunshine Cathedral have established a financial relationship with OUR FUND, a community endowment fund dedicated to supporting organizations and functions of the LGBTQ community.

#### 5. ABOUT THE SUNSHINE CATHEDRAL FOUNDATION

The Sunshine Cathedral Foundation was established to secure a home for the Sunshine Cathedral.

MISSION: To support the mission and vision of the Sunshine Cathedral and future capital, building and property needs by maintaining an active Board of Governors and by organizing outreach and/or fund-raising efforts.

ORGANIZATION:

The Foundation is a 501 c (3) not-for-profit organization governed by a Board of Governors which is comprised of dedicated individuals who are Cathedral members and/or LGBT community supporters.
